What is the Smart Export Guarantee (SEG)?

Under the Smart Export Guarantee (SEG) you will be paid for every unit of electricity that you feed back. You won't be paid for any that you use yourself. You need to have a renewable electricity generating system that meets the SEG eligibility requirements. You must have a meter capable of providing half-hourly export readings.

Can I export solar energy?

However, solar storage is covered by the SEG in some instances, meaning that if you export stored energy you could still qualify for the export tariff. This differs with suppliers, though, so be sure to consult your licensee first. Hydropower, energy that you generate from water, is another popular choice for renewable electricity.

How do I get a Smart Export Guarantee?

Get in touch with your energy supplier to see if they offer this. The Smart Export Guarantee is a support mechanism that ensures people that generate their own electricity are paid for electricity they export to the grid. This doesn't happen automatically, so you need to sign up to get the SEG tariff.

How much money did Smart Export Guarantee generators get paid?

In the same period, £30.7 million was paid out to Smart Export Guarantee generators, an incredible 327% on the £7.2 million paid between 2022-2023. On top of that, between 2023-2024 238 GWh of electricity was exported back to the grid, which was enough to power 88,198 UK homes for a year.
