What are Vietnam electric mobility incentives?

At the heart of Vietnam Electric Mobility Incentives are sweeping measures to cut upfront expenses for buyers. From March 2022, registration fees for battery electric vehicles were set at 0% for three years. After this period, fees will remain discounted by 50% for two additional years.

Why is Vietnam allowing a zero percent registration fee for electric cars?

The decree allowing a zero percent registration fee for battery-powered electric cars until February 28, 2027, is a strategic move to promote clean transportation. In Vietnam, the registration fee is a significant cost when purchasing a vehicle. The percentage varies by locality and vehicle type.

What if EV registration fees expired in Vietnam?

Since 2022, Vietnam has provided a full exemption on EV registration fees for three years, followed by a 50 percent reduction for the subsequent two years. Without further action, this incentive would have expired on February 28, 2025, requiring EV buyers to cover 50 percent of the registration fee.
